RESOLUTION NUMBER 4568

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA GRANDE, OREGON, ESTABLISHING STREET USER FEES; REPEALING RESOLUTION NUMBER 4155, SERIES 1992, ALL AMENDING RESOLUTIONS, AND ALL OTHER RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND DECLARING AN EFFECTIVE DATE OF AUGUST 1, 2009

WHEREAS, the City Council of the City of La Grande, Oregon, adopted Ordinance Number 2708, Series 1985, establishing a Street User Fee within the City of La Grande, Oregon; and,

WHEREAS, the fees collected are to be placed in a Street Fund, for exclusive financial support of street reconstruction, major maintenance, and repair of streets; and,

WHEREAS, the streets to be benefited are those paved, dedicated streets which are open to public travel; and,

WHEREAS, the City Council of the City of La Grande, Oregon, finds there is a need to reconstruct, maintain and repair streets beyond the funding capacity of general revenues of the City of La Grande, Oregon; and,

WHEREAS, the City Council of the City of La Grande, Oregon, has resolved to collect a Street User Fee and has directed the Finance Director of the City of La Grande, Oregon, to bill for said fees on a monthly basis;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of La Grande, Oregon, that the following Street User Fees shall be and hereby are established; and,

BE IT FURTHER RESOLVED by the City Council of the City of La Grande, Oregon, that utility rate payers over the age of sixty-five (65) and paying a discounted water rate shall also receive a fifty percent (50%) discount per month on their Street User fees.





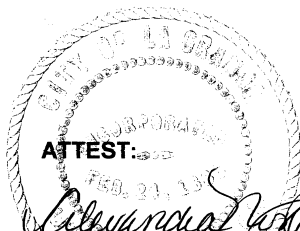
