UTILITY LICENSE APPLICATION

Pursuant to the City of La Grande's Utility Licensing Ordinance Number 3245, Series 2019, every person who operates a Utility in the Right of Way (as defined in the Ordinance) shall obtain a Utility License from the City.

Instructions: Please provide all information requested below, including applicable application fees, to the City Manager's office. The application must be signed by an authorized representative of the entity requesting a license. If the applicant is a foreign person or a non-resident of the State of Oregon and no permanent office location is proposed to be created in the City, the applicant must appoint a local person, acceptable to the Manager, as an agent for accepting service of process, notice and/or demand. The applicant must submit with the application the agent's consent to acceptance of service of process, notice, and/or demand. An applicant may request that the City exempt the applicant from the requirement to maintain an office in the City.

The City will review the information and, if approved, will return a copy of the application executed by the City which will serve as the license required by the Utility Licensing Ordinance.
