
Discussion during the upcoming Council work session will be centered on the Eastside Water and Sewer Funding Project and the potential funding opportunities that currently exist. This venture was identified as one of the several funding opportunities that were presented during the process of selecting projects for funding with the City's American Recovery Plan Act (ARPA) funds. The project consists of constructing water and sewer service mains to remove the existing infrastructure gap to a large area of potential residential development. Attached are two (2) exhibit maps showing the project area with approximate locations for water/sewer infrastructure and a previously proposed subdivision located within the project area, which contained one hundred and ninety three (193) buildable lots. In reference to the entire affected area of the Eastside Water and Sewer Funding Project, the subject development would represent the first of multiple phases that would result from the construction of the utility infrastructure.

Motivation for moving forward with this project is directly related to the findings of the City's Housing Needs Analysis, which concluded that La Grande is deficient in every housing category. Identified as one of the major districts for potential residential housing that currently lies within the City's Urban Growth Boundary, the project area is currently unappealing to private developers due to the high up-front costs associated with needed water and sewer infrastructure that spans multiple property ownerships well outside of any one development area. Previous interest in the former subdivision property has been significant with multiple developers looking at funding alternatives (e.g. grants, city participation, etc.) to bridge the gap and make a residential project cost effective. Currently, there are no parties known to City Staff that are actively looking at the available properties within the project area; however, this could be attributed to the present state of the construction development and housing markets and the high cost of needed off-site infrastructure improvements.

Financing the construction of the sewer and water infrastructure for the project area has previously (October 2022) been estimated at \$2,900,000, if the entire project window was completed at one time. The project is able to be phased in up to three (3) phases, which would bring the up-front cost for the initial phase to an estimated \$1,500,000. Avenues for the City to obtain this funding include self-funding the project with reserve funds and recapturing the dollars when development occurs through System Development Charges (SDCs) and pursuing possible grant funding. City staff has recently been introduced to a new grant funding source that has the potential to provide funding toward housing development and is working with Northeast Oregon Economic Development District (NOEDD) to ascertain viability. Preliminary timelines point to more information being available in early 2024. Utilizing either option, the City would not only recover invested dollars upon construction, but the completed development would bring additional revenue through property taxes, utility rents, etc., to multiple City departments, including the general fund and public works.

Considering the limited availability of developable property in La Grande, the identified need for all housing in every category and the rapidly escalating costs in the housing sector, the Eastside Water and Sewer Funding Project is a practical solution to many important City issues. Though cost recovery can be drawn out based on the City's past history in similar ventures, the projections on cost inflation into the future support the viability of the investment.
